## **Medical Benefits Abroad (MBA)**

### **Benefits at a Glance (BAAG)**

**Politico Media Group, LLC - 10138A**

The insurance benefits and the provisions of the group policy principally affecting the persons insured are described below. The policy covers unexpected Medical Illness and Injury Services and Urgent Care worldwide. The final interpretation of any specific provision herein is governed by the terms of the policy.

#### **Eligibility for Member Insurance**

- you are in a Class of Eligible Members as determined by the Group and covered under the Group's health plan or other comprehensive health coverage in your country of residence or permanent assignment if outside the United States;
- you are traveling outside your country of residence or permanent assignment for no more than 180 consecutive days per trip on the business of, or at the expense of, the Group or on Sojourn Travel; and
- you pay any required contribution.

#### **Eligibility for Dependent Insurance**

- the day you become eligible for yourself; or
- the day you acquire your first Dependent if that Dependent is traveling with you outside their country of residence or permanent assignment for no more than 180 consecutive days per one trip on the business of, or at the expense of, the Group or on Sojourn Travel. Dependents are not eligible for Accidental Death and Dismemberment coverage.

Persons for whom coverage is prohibited under applicable law or sanctions rules will not be considered eligible under this plan. The effective date of this Schedule of Benefits is 9/1/2025.

<b>Pre-Existing Conditions</b>	Covered, subject to the calendar year medical maximum
<b>War Risk (Medical)</b>	Not Covered
<b>War Risk (AD&amp;D)</b>	Not Covered

<b>Crisis Assistance Plus (CAP)</b>	Includes crisis consulting at no dollar limit per person per covered expense. The number of physical responses/evacuations incurring in a year are limited to two per person per year. <sup>2</sup>
<b>Occupational Accident</b>	Not Covered
